3 A RESOLUTION OF THE RIALTO HOUSING AUTHORITY  
4 BOARD OF THE CITY OF RIALTO, CALIFORNIA, ADOPTING  
5 THE FISCAL YEAR 2021/2022 BUDGET

6 WHEREAS, the proposed budget for fiscal year 2021/2022 of the Rialto Housing Authority  
7 (Authority or RHA) has been submitted to the Authority Board, and said budget has been considered  
8 and, is in form and substance satisfactory to the Authority Board; and

9 WHEREAS, the Authority may not exceed its appropriations by character of expense, with  
10 character of expense being defined as personnel services, services and supplies, capital outlay, debt  
11 service and transfers, without the consent of the Authority Board; and

12 WHEREAS, the Executive Director may transfer appropriations, between departments and  
13 within their respective funds, as long as those appropriations do not exceed their fund total unless  
14 approved by the Authority Board; and

15 WHEREAS, the Executive Director is authorized to make changes to the Adopted Budget only  
16 to accommodate actual fund balance as determined at year end and any technical balancing adjustments  
17 to appropriations, revenue, and available reserves; and

18 WHEREAS it is the intent to ensure that maximum efficiency and savings are realized within  
19 the Authority Board; and

20 WHEREAS, the inter-fund borrowings arising from deficit spending in any fund shall require  
21 Authority Board action to provide for appropriate repayment terms and conditions; and

22 NOW, THEREFORE, THE RIALTO HOUSING AUTHORITY BOARD OF THE CITY  
23 OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

24 **Section 1:** That the budget for the Rialto Housing Authority for the fiscal year 2021/2022 is  
25 hereby approved and adopted in the form on file with the City Clerk.

26 **Section 2:** That specific appropriations for the fund and operating department(s) are hereby  
27 made as set forth in the budget for fiscal year 2021/2022, which are incorporated herein by this  
28 reference.
