A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, AUTHORIZING THE COLLECTION OF SOLID WASTE HANDLING SERVICE CHARGES ON THE PROPERTY TAX ROLL

WHEREAS, Chapter 8.08 of the City of Rialto Municipal Code and California Health and Safety Code Section 5473 et. seq. authorizes the City to adopt a resolution by two-thirds of the members of the City Council to collect solid waste handling rates on the tax roll, in the same manner and at the same time as the general taxes; and,

WHEREAS, the City Council adopted Resolution 8109 on June 27, 2023, after providing public notice and a protest hearing in accordance with Proposition 218, setting the maximum solid waste collection rates by fiscal year that may be charged for the fiscal years 2023/2024 through 2026/2027; and,

WHEREAS, in accordance with Health and Safety Code Section 5473, City staff has prepared a written report, attached hereto as Exhibit A and on file with the City Clerk, which contains a description of each parcel of real property subject to tax roll billing and the amount of the fees and charges for each parcel; and,

WHEREAS, in accordance with Health and Safety Code Section 5473.1, the City provided notice of a public hearing by publishing a notice in the San Bernardino Sun newspaper on July 7th and July 14th, 2025; and,

WHEREAS, the City Council conducted a duly noticed public hearing on this matter on July 22, 2025, wherein it heard and considered all objections or protests, if any, to the report and the proposed placement of solid waste handling services charges and fees on the property tax roll.

1	NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY
2	FIND, DETERMINE, AND RESOLVE AS FOLLOWS:
3	Section 1: The above recitals are true and correct and are incorporated herein.
4	Section 2: The City approves the collection of the solid waste handling services
5	charges and fees via the tax roll in the same manner and at the same time as the general
6	taxes. The City Clerk is directed to file with the county auditor a copy of the report prepared
7	pursuant to Health and Safety Code Section 5473 attached hereto as Exhibit A, with a
8	statement endorsed on the report over his or her signature that the report has been adopted
9	by the City Council and the county auditor shall enter the amounts of the charges against the
10	respective lots or parcels of land as they appear on the current assessment roll.
