3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
4 RIALTO, CALIFORNIA, AUTHORIZING THE COLLECTION OF  
5 SOLID WASTE HANDLING SERVICE CHARGES ON THE  
6 PROPERTY TAX ROLL

7 WHEREAS, Chapter 8.08 of the City of Rialto Municipal Code and California Health  
8 and Safety Code Section 5473 et. seq. authorizes the City to adopt a resolution by two-thirds  
9 of the members of the City Council to collect solid waste handling rates on the tax roll, in the  
10 same manner and at the same time as the general taxes; and,

11 WHEREAS, the City Council adopted Resolution 8109 on June 27, 2023, after providing  
12 public notice and a protest hearing in accordance with Proposition 218, setting the maximum  
13 solid waste collection rates by fiscal year that may be charged for the fiscal years 2023/2024  
14 through 2026/2027; and,

15 WHEREAS, in accordance with Health and Safety Code Section 5473, City staff has  
16 prepared a written report, attached hereto as Exhibit A and on file with the City Clerk, which  
17 contains a description of each parcel of real property subject to tax roll billing and the amount  
18 of the fees and charges for each parcel; and,

19 WHEREAS, in accordance with Health and Safety Code Section 5473.1, the City  
20 provided notice of a public hearing by publishing a notice in the San Bernardino Sun  
21 newspaper on July 7<sup>th</sup> and July 14<sup>th</sup>, 2025; and,

22 WHEREAS, the City Council conducted a duly noticed public hearing on this matter on  
23 July 22, 2025, wherein it heard and considered all objections or protests, if any, to the report  
24 and the proposed placement of solid waste handling services charges and fees on the property  
25 tax roll.

The City Clerk is directed to file with the county auditor a copy of the report prepared pursuant to Health and Safety Code Section 5473 attached hereto as Exhibit A, with a statement endorsed on the report over his or her signature that the report has been adopted by the City Council and the county auditor shall enter the amounts of the charges against the respective lots or parcels of land as they appear on the current assessment roll.
