4 **WHEREAS**, the City Council conducted a duly noticed public hearing to solicit public comments  
5 on Substantial Amendment No. 1 to the Fiscal Year 2024–2025 Annual Action Plan.

7 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF  
8 RIALTO AS FOLLOWS:

10 Section 1. The City Council hereby adopts **Substantial Amendment No. 1 to the Fiscal**  
11 **Year 2024–2025 Annual Action Plan**, which reallocates \$100,000 in CDBG funds from the Building  
12 500 Rehabilitation Project to the Carl Johnson Center rehabilitation project.

13  
14 Section 2. The City Council hereby authorizes the **City Manager or their designee to**  
15 **submit Substantial Amendment No. 1** to the Fiscal Year 2024–2025 Annual Action Plan to the U.S.  
16 Department of Housing and Urban Development (HUD).

17  
18 Section 3. The City Council hereby authorizes the **City Manager or their designee to take**  
19 **all actions necessary to implement the programs identified** in the amended Fiscal Year 2024–2025  
20 Annual Action Plan.

21  
22 Section 4. The City Council hereby authorizes the **City Manager or their designee to make**  
23 **all conforming modifications and edits, and to execute all implementing documents required by**  
24 **HUD**, in a form approved by the City Attorney.

26 Section 5. This resolution shall take effect immediately upon its passage.
