General Plan Amendment No. 2022-0003: A request to change the general plan land use designation of approximately 101.7 acres of land (APNs: 0264-191-02, -04, -13, & -14 and 0264-201-08, -25, -27, -28, -29, -30, & -31) generally located east of Eucalyptus Avenue, south of the SR-210 Freeway, west of Meridian Avenue, and north of Walnut Avenue from a mix of Residential 6 and Business Park to Specific Plan with a Specific Plan Overlay. The City Council of the City of Rialto certified an Environmental Impact Report for the project on December 12, 2017 (Resolution No. 7259). (Applicant: City of Rialto)

**Zone Change No. 2022-0001:** A request to change the zoning designation of approximately 101.7 acres of land (APNs: 0264-191-02, -04, -13, & -14 and 0264-201-08, -25, -27, -28, -29, -30, & -31) generally located east of Eucalyptus Avenue, south of the SR-210 Freeway, west of Meridian Avenue, and north of Walnut Avenue from a mix of Single-Family Residential (R-1A) and Commercial Manufacturing (C-M) to Pepper Avenue Specific Plan. The City Council of the City of Rialto certified an Environmental Impact Report for the project on December 12, 2017 (Resolution No. 7259). (Applicant: City of Rialto)
