3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
4 RIALTO, CALIFORNIA, ACCEPTING GRANT FUNDING FOR
5 THE SMART CORRIDOR: RIVERSIDE AVENUE PROJECT.

6 WHEREAS, the budget for fiscal year 2025-2026 of the City of Rialto has been
7 adopted by this Council in its original form, and said budget will need to be amended at times
8 to fulfill the goals of the City; and

9 WHEREAS, the City departments may not exceed their appropriations by character of
10 expense, with character of expense being defined as personnel services, services and
11 supplies, capital outlay, debt service and transfers, without the consent of the City
12 Administrator; and

13 WHEREAS, the City Manager may transfer appropriations between departments and
14 within their respective funds, as long as those appropriations do not exceed their fund total
15 unless approved by Council.

16 NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES
17 HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

18 Section 1: Accept grant funding for the development of Smart Arterial Corridor in
19 the San Bernardino Valley and increase revenues of \$976,750 in the Project fund, Account
20 No. 22234429-47536, and appropriate the corresponding expenditures in account number
21 22234429-53001 for the Smart Corridor: Riverside Avenue project.

22 Section 2: Authorize the appropriation of \$225,000 in the Measure I Fund, Account
23 No. 22014310-53001, for the local match requirement for the Smart Corridor: Riverside
24 Avenue project.
