## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, ACCEPTING GRANT FUNDING FOR THE SMART CORRIDOR: RIVERSIDE AVENUE PROJECT.

WHEREAS, the City departments may not exceed their appropriations by character of
expense, with character of expense being defined as personnel services, services and
supplies, capital outlay, debt service and transfers, without the consent of the City
Administrator; and

WHEREAS, the City Manager may transfer appropriations between departments and
within their respective funds, as long as those appropriations do not exceed their fund total
unless approved by Council.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

<u>Section 1:</u> Accept grant funding for the development of Smart Arterial Corridor in
 the San Bernardino Valley and increase revenues of \$976,750 in the Project fund, Account
 No. 22234429-47536, and appropriate the corresponding expenditures in account number
 22234429-53001 for the Smart Corridor: Riverside Avenue project.

**Section 2:** Authorize the appropriation of \$225,000 in the Measure I Fund, Account No. 22014310-53001, for the local match requirement for the Smart Corridor: Riverside Avenue project.
