2           WHEREAS, City has defined and established by Council Resolution a policy and  
3 administrative guidelines to provide for wastewater service outside the City’s corporate boundaries;  
4 and

5  
6           WHEREAS, in order to accommodate the conveyance, treatment and disposal of wastewater  
7 originating in the Service Area, City has agreed to maintain and/or construct the Rialto Disposal System  
8 and such related and/or additional facilities as may be necessary to adequately provide such service for  
9 the Service Area in perpetuity; and

10  
11           WHEREAS, in consideration of City’s agreement to provide adequate conveyance, treatment  
12 and disposal services to the Service Area, Owners have agreed to make payments described in an  
13 Extraterritorial Wastewater Service Agreement with respect to wastewater from the Property  
14 discharged into the Rialto Disposal System (such wastewater being “Service Area Wastewater”)  
15 calculated at one point three (1.3) times the monthly rates charged by City to customers within Rialto,  
16 all on terms and conditions more fully set forth therein.

17  
18           NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF  
19 RIALTO AS FOLLOWS:

21           Section 1. An Extraterritorial Wastewater Service Agreement (the “Agreement”) authorizing  
22 wastewater service to the property located at 19010 Valley Boulevard, Bloomington, CA, two blocks west  
23 of Spruce Avenue, identified by Assessor Parcel Number 0253-123-47-0000, is hereby approved as  
24 submitted to the City Council concurrently with its adoption of this Resolution.
