The City received a total of \$1,339,584 in CDBG-CV funds. When a substantial change (i.e., adding an activity, canceling an activity, or redirecting funds) is proposed to the City's Annual Action Plan, the City requires that the public be notified, and a Public Hearing be held to allow the public an opportunity to comment on the proposed substantial changes.
