A PROPOSED SUBSTANTIAL AMENDMENT TO
FISCAL YEAR (FY) 2020-2021 ANNUAL ACTION PLAN

NOTICE IS HEREBY GIVEN that the City of Rialto (City) will conduct a public hearing on Tuesday, July 22, 2025, to receive public comment for the proposed Substantial Amendment No. 7 to the Fiscal Year (FY) 2020-2021 Annual Action Plan. This amendment is conducted in accordance with guidance provided by the U.S. Department of Housing and Urban Development. The publication of this notice is the beginning of the 15-day public review period required under Federal Regulations at [24 CFR 91.105](#), and as approved by the Citizen Participation Plan. The public review and written comment period begin June 27, 2025, and will run through July 12, 2025.

NOTICE IS HEREBY FURTHER GIVEN that the proposed Substantial Amendment No. 7 to the Fiscal Year (FY) 2020-2021 Annual Action Plan will be presented to the City Council for approval on the following date:

At this meeting, the City Council will receive public comment on the proposed Substantial Amendment No. 7 to the Fiscal Year (FY) 2020-2021 Annual Action Plan that will be submitted to the U.S. Department of Housing and Urban Development (HUD).

BACKGROUND

The FY 2020-2021 Annual Action Plan sets forth specific activities and expenditures using funds received through the supplemental Community Development Block Grant COVID-19 (CDBG-CV) program, administered by the U.S. Department of Housing and Urban Development. The City received a total of \$1,339,584 in CDBG-CV funds.

When a substantial change (i.e., adding an activity, canceling an activity, or redirecting funds) is proposed to the City's Annual Action Plan, the City requires that the public be notified, and a Public Hearing be held to allow the public an opportunity to comment on the proposed substantial changes.

The City Council will conduct a public hearing on Tuesday, July 22nd, 2025, for the adoption of Substantial Amendment No.7. The City must however expend 100% of their CDBG-CV funds by February 2027. An Ad-Hoc Committee Meeting was held on Thursday, May 29th, 2025, to consider the modification of CDBG-CV programs and activity funding levels. Based on feedback staff received during the May 29th Ad-Hoc Committee Meeting, the following recommendations are presented to the community and the City Council for consideration.
