A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, APPROVING AND ADOPTING A TWO-YEAR MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF RIALTO AND THE RIALTO POLICE BENEFIT ASSOCIATION- MANAGEMENT UNIT COMMENCING ON JULY 1, 2025, THROUGH JUNE 30, 2027

WHEREAS, The City of Rialto (hereinafter referred to as the "City") and the Rialto Police Benefit Association – Management Unit (hereinafter referred to as "Association") have met and conferred over wages, hours, terms, and conditions of employment pursuant to Government Code 3500, as amended; and

WHEREAS, the City and the Association have agreed to the terms of a Memorandum of Understanding for a period of two years, commencing on July 1, 2025, through June 30, 2027.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

Section 1: The City does hereby approve, ratify, and authorize the implementation of each economic and non-economic benefit and right set forth in the Memorandum of Understanding between the City and the Association, attached hereto and incorporated herein by this reference as Exhibit "1", and said economic and non-economic benefits and rights shall be implemented to the extent the City may legally do so in accordance with time constraints of said Memorandum of Understanding. The Director of Human Resources/Risk Management is authorized to make minor clerical/non-substantive changes to the MOU so long as such changes do not in any manner change the economic and non-economic benefits and rights of the parties.
