

RESOLUTION NO.____

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, AMENDING THE CAPITAL IMPROVEMENT PROGRAM AND AMENDING ITS 2022-2023 FISCAL BUDGET INCRESING THE "BIRDSALL PARK IMPROVEMENT PROJECT, CITY PROJECT NO. 210304," AND INCREASE THE BUDGET BY \$1,617,950.

WHEREAS, the budget for fiscal year 2022-2023 of the City of Rialto has been adopted by this Council in its original form, and said budget will need to be amended at times to fulfill the goals of the City; and

WHEREAS, the City departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the City Administrator; and

WHEREAS, the City Manager may transfer appropriations between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Council.

WHEREAS, the City Council of the City of Rialto requires a five-year Capital Improvement Program (CIP), which is updated annually; and

WHEREAS, the CIP may be amended from time to time to include additional capital improvement projects that were not originally identified in the CIP adopted by the City Council.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

<u>Section 1</u>: Approve a revenue increase in the City's Community Services Grant Fund, Account No. 248-400-7304-7560 of \$1,617,950 for a Funding Agreement with the County of San Bernardino.

<u>Section 2</u>: Approve an appropriation from the Community Services Grant Fund, Account No. 248-500-7304-3001, in the amount of \$1,617,950.

1	Section 3: Transfer money within the Capital Improvement Program (CIP);
2	\$1,000,000 allocated for the Fitness Conversion in Account No. 300-500-8345-3001to the
3	Birdsall Park Project, City Project No. 210304, Major Capital Fund, Account No. 300-500-7304-
4	3001.
