A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA RECEIVING AND APPROVING A RESOLUTION AUTHORIZING THE CITY MANAGER, OR DESIGNEE TO SUBMIT TO HUD THE CITY'S FISCL YEAR (FY) 2021-2022 CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT (CAPER) AND RATIFY THE AMENDED FY 2021-2022 CDBG BUDGET ALLOCATION.

WHEREAS, the City of Rialto (the "City") has applied and received Community Development Block Grant (CDBG) funds from the U.S. Department of Housing and Urban Development (HUD; and

WHEREAS, pursuant to Title 24 of the Codes of Federal Regulations, the City is required to submit a Consolidated Annual Performance and Evaluation Report (CAPER) to HUD, detailing the City's uses of CDBG funds during the 2021-2022 Fiscal Year; and

WHEREAS, the City's is amending the allocation for their Section 108 loan to \$489,383.28, an increase of \$56,122.28: and

WHEREAS, the City has prepared this CAPER and provided opportunities to receive public comments during a 15-day public review period through a notice of availability duly published in the San Bernardino County Sun on September 13, 2022; and

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY
RESOLVE AS FOLLOWS:**

SECTION 1. The above recitals are true and correct and incorporated herein by reference.

SECTION 2. The City Council of the City of Rialto does hereby approve the CAPER for Fiscal Year 2021-2022.

SECTION 3. The City Manager is hereby authorized to take reasonable action needed to implement this Resolution, including submittal of the CAPER to the appropriate HUD office on behalf of the City.

SECTION 4. The City Clerk shall certify to the adoption of this Resolution which shall be effective upon its adoption.
