<u>Precise Plan of Design No. 2022-0025:</u> Site and architectural review of a proposal to develop a 21-unit apartment complex with 5 Accessory Dwelling Units consisting of eight (8) two-story buildings and associated improvements on a 1.67-acre parcel of land (APN: 0130-013-02) located on the east side of Cactus Avenue approximately 360 feet south of Foothill Boulevard within the Foothill Boulevard Specific Plan.
