A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, AMENDING ITS 2023-2024 FISCAL BUDGET AND APPROPRIATING \$196,200 TO THE HIGHWAY SAFETY IMPROVEMENT PROJECT CLASS II BIKE LANES ON MERRILL AVENUE AND RIVERSIDE AVENUE, PROJECT NO. 170813.

WHEREAS, the budget for fiscal year 2023-2024 of the City of Rialto has been adopted by this Council in its original form, and said budget will need to be amended at times to fulfill the goals of the City; and

WHEREAS, the City departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the City Administrator; and

WHEREAS, the City Manager may transfer appropriations, between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Council.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND. DETERMINE. AND RESOLVE AS FOLLOWS:

Section 1: Approve an appropriation from Gas Tax Fund, Account No. 22024317-53001-170813-23 in the amount of \$196,200 for the Class II Bike Lanes on Merrill Avenue and Riverside Avenue, Federal Project No. HSIP 5205-024, City Project No.170813.
