A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO DECLARING RESULTS OF SPECIAL ELECTION, DETERMINING THAT CERTAIN TERRITORY IS ADDED TO AND PART OF CITY OF RIALTO COMMUNITY FACILITIES DISTRICT NO. 2016-1 (PUBLIC SERVICES) (ANNEXATION NO. 8) AND DIRECTING RECORDING OF A NOTICE OF ANNEXATION

WHEREAS, on July 22, 2025, the City Council (the "City Council") of the City of Rialto (the "City"), pursuant to the Mello-Roos Community Facilities Act of 1982 (the "Act"), adopted a resolution entitled "A Resolution of the City Council of the City of Rialto of Intention to Annex Territory to City of Rialto Community Facilities District No. 2016-1 (Public Services) and to Authorize the Levy of Special Taxes Therein" stating its intention to annex certain territory (the "Additional Territory") to City of Rialto Community Facilities District No. 2016-1 (Public Services) (the "Community Facilities District"), and to authorize the levy of special taxes (the "Special Taxes") within the Additional Territory to provide and finance certain public services (the "Services"), and setting August 26, 2025 as the date for a public hearing to be held on the proposed annexation of the Additional Territory to the Community Facilities District;

WHEREAS, on August 26, 2025, the City Council adopted a resolution entitled "A Resolution of the City Council of the City of Rialto Calling a Special Election to Levy a Special Tax Within Territory Proposed to be Annexed to City of Rialto Community Facilities District No. 2016-1 (Public Services) (Annexation No. 8)" (the "Resolution Calling Election"), calling for a special election to submit to the qualified electors of the Additional Territory the proposition to levy the Special Taxes within the Additional Territory in order to finance the Services;

WHEREAS, pursuant to the terms of the Resolution Calling Election and the provisions of the Act, the special election was held on August 26, 2025; and
