2 WHEREAS, Rialto Utility Authority has defined and established by Resolution a policy and  
3 administrative guidelines to provide for wastewater service outside the City’s corporate boundaries;  
4 and

5  
6 WHEREAS, in order to accommodate the conveyance, treatment and disposal of wastewater  
7 originating in the Service Area, Rialto Utility Authority has agreed to maintain and/or construct the  
8 Rialto Disposal System and such related and/or additional facilities as may be necessary to adequately  
9 provide such service for the Service Area in perpetuity; and

10  
11 WHEREAS, in consideration of Rialto Utility Authority’s agreement to provide adequate  
12 conveyance, treatment and disposal services to the Service Area, Owner have agreed to make payments  
13 described in an Extraterritorial Wastewater Service Agreement with respect to wastewater from the  
14 Property discharged into the Rialto Disposal System (such wastewater being “Service Area  
15 Wastewater”) calculated at one point three (1.3) times the monthly rates charged by City to customers  
16 within Rialto, all on terms and conditions more fully set forth therein.

17  
18 NOW, THEREFORE, BE IT RESOLVED BY THE RIALTO UTILITY AUTHORITY OF  
19 THE CITY OF RIALTO AS FOLLOWS:

21 Section 1: An Extraterritorial Wastewater Service Agreement (the “Agreement”) authorizing  
22 wastewater service to the property located at 19010 Valley Boulevard, Bloomington, CA, two blocks west  
23 of Spruce Avenue, identified by Assessor Parcel Number 0253-123-47-0000, is hereby approved as  
24 submitted to the Rialto Utility Authority concurrently with its adoption of this Resolution.
