3 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF**
4 **RIALTO, STATE OF CALIFORNIA, COMMUNITY FACILITIES**
5 **DISTRICT NO. 87-2 (LAS COLINAS) ESTABLISHING ANNUAL**
6 **SPECIAL TAX FOR FISCAL YEAR 2020-21**

7 **WHEREAS**, The City Council of the City of Rialto, California, (hereinafter referred to as the
8 “legislative body”), has initiated proceedings, held a public hearing, conducted an election and received
9 a favorable vote from the qualified electors relating to the levy of a special tax in a community facilities
10 district, all as authorized pursuant to the terms and provisions of the “Mello-Roos Community Facilities
11 Act of 1982”, being Chapter 2.5, Part 1, Division 2, Title 5 of the Government Code of the State of
12 California. This Community Facilities District shall hereinafter be referred to as “District”; and

13 **WHEREAS**, this legislative body, by Resolution as authorized by Section 53340 of the
14 Government Code of the State of California, has authorized the levy of a special tax to pay for costs and
15 expenses related to said Community Facilities District, and this legislative body is desirous to establish
16 the specific rate of the special tax to be collected for the fiscal year.

17 **NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES**
18 **HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

19 **Section 1:** That the above recitals are all true and correct.

20 **Section 2:** That the specific rate and amount of the special tax to be collected to pay for the
21 costs and expenses for the next fiscal year 2020-21 for the referenced District is hereby determined and
22 established to be zero (\$0).

23 **Section 3:** That the rate as set forth above does not exceed the amount as previously
24 authorized by Resolution of this legislative body, and is not in excess of that as previously approved by
25 the qualified electors of the District, and is exempt from Article XIID Section 4 of the California State
26 Constitution.

27 **Section 4:** That any proceeds of the special tax would have been used to pay, in whole or in
28 part, the costs of the following:

A. Payment of principal of and interest on any outstanding authorized bonded indebtedness;

- 1 B. Necessary replenishment of bond reserve funds or other reserve funds;
- 2 C. Payment of costs and expenses of authorized public facilities;
- 3 D. Repayment of advances and loans, if appropriate, and,
- 4 E. Payment of District administrative costs.

5 The proceeds of the special taxes would be used as set forth above, and would not be used for
6 any other purpose.

7 **Section 5:** The special tax would be collected in the same manner as ordinary ad valorem
8 property taxes are collected, and would be subject to the same penalties and same procedure and sale in
9 cases of any delinquency for ad valorem taxes, and the Tax Collector is hereby authorized to deduct
10 reasonable administrative costs incurred in collecting any said special tax.

11 **Section 6:** The Auditor of the County is hereby directed to enter in the next County
12 assessment roll on which taxes will become due, opposite each lot or parcel of land effected in a space
13 marked "public improvements, special tax" or by any other suitable designation, the installment of the
14 special tax, and for the exact rate and amount of said tax, reference is made to in section 2.
