11	WHEREAS, revenue from the tax can only be used for transportation improvement
12	and traffic management programs authorized in the Expenditure Plans set forth in Ordinance
13	No. 04-01 of the Authority; and
14	WHEREAS, the Strategic Plan requires each local jurisdiction applying for revenue
15	from the Local Street Program to annually adopt and update a Five-Year Capital
16	Improvement Plan; and

18	NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES
19	HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

21	Section 1: That the City of Rialto hereby adopts the Measure I Five-Year Capital
22	Improvement Plan and the Expenditure Strategy as submitted to the City Council with the
23	adoption of this resolution, attached as <b>Exhibit A</b> and <b>Exhibit B</b> .
