A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, AMENDING THE FISCAL YEAR 2025-2026 CAPITAL IMPROVEMENT PROJECT BUDGET TO INCORPORATE SAN BERNARDINO COUNTY PARK PROJECT FUNDS

WHEREAS, the budget for fiscal year 2025-2026 of the City of Rialto has been adopted by this Council in its original form, and said budget will need to be amended at times to fulfill the goals of the City; and

WHEREAS, the City departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the City Manager; and

WHEREAS, the City Manager may transfer appropriations, between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Council.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES
HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

Section 1: Authorize an increase in revenue in the Parks and Recreation Account No. 22488813-47560 in the amount of \$323,000 from San Bernardino County for the Carl Johnson Center Gym Winches and Bleachers Project (\$203,000) and the Fergusson Park Outdoor Court Renovation and Conversion Project (\$120,000).

Section 2: Approve the following appropriations in the Parks and Recreation expense Account No. 22488813-53050 in the amount of \$323,000 for the Carl Johnson Center Gym Winches and Bleachers Project (\$203,000) and the Fergusson Park Outdoor Court Renovation and Conversion Project (\$120,000).
