**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
RIALTO, CALIFORNIA, AMENDING ITS 2018-2019 FISCAL  
BUDGET AND APPROVING THE APPLICATION FOR THE  
EDWARD BYRNE MEMORIAL JUSTICE GRANT (JAG)**

**WHEREAS**, the budget for fiscal year 2018-2019 of the City of Rialto has been adopted by this Council in its original form, and said budget will need to be amended at times to fulfill the goals of the City; and

**WHEREAS**, the City departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the City Administrator; and

**WHEREAS**, the City Administrator may transfer appropriations, between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Council.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES  
HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

**Section 1:** Approve the application for the Edward Byrne Memorial Justice Grant (JAG).

**Section 2:** Authorize an increase in estimated revenues in the amount of \$28,457 in General Fund, Account No. 213-400-6979-7540; and

**Section 3:** Approve an appropriation of \$28,457 in General Fund, Account No. 213-500-6979-2021 for the Edward Byrne Memorial Justice Assistance Grant (JAG).
