3 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF**  
4 **RIALTO, CALIFORNIA, FOR PAYING AND REPORTING THE**  
5 **VALUE OF EMPLOYEE MEMBER PAID CONTRIBUTIONS**

6 **WHEREAS**, the governing body of the City of Rialto has the authority to implement  
7 Government Code Section 20636 (c) (4) pursuant to section 20691; and

8 **WHEREAS**, the governing body of the City of Rialto has a written labor policy or agreement  
9 which specifically provides for the normal member contributions to be paid by the employer, and  
10 reported as additional compensation; and

11 **WHEREAS**, one of the steps in the procedures to implement Section 20691 is the adoption by  
12 the governing body of the City of Rialto of a Resolution to commence paying and reporting the value of  
13 said Employer Paid Member Contributions (EPMC); and

14 **WHEREAS**, the governing body of the City of Rialto has identified the following conditions for  
15 the purpose of its election to pay EPMC;


- 16 • This benefit shall apply to all employees of the Rialto Police Management bargaining  
17 unit.
- 18 • This benefit shall consist of paying 7% of the normal contributions as EPMC, and  
19 reporting the same percent (value) of compensation earnable (excluding Government  
20 Code Section 20636 (c) (4)) as additional compensation for the miscellaneous employees.
- 21 • This benefit shall consist of paying 9% of the normal contributions as EPMC, and  
22 reporting the same percent (value) of compensation earnable (excluding Government  
23 Code Section 20636 (c) (4)) as additional compensation for the safety employees.
- 24 • The effective date of this Resolution shall be April 1, 2010.

25 **NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES**  
26 **HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**


27 That the governing body of the City of Rialto elects to pay and report the value of EPMC, as set


