RESOLUTION NO.5803

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, FOR PAYING AND REPORTING THE VALUE OF EMPLOYEE MEMBER PAID CONTRIBUTIONS

WHEREAS, the governing body of the City of Rialto has the authority to implement Government Code Section 20636 (c) (4) pursuant to section 20691; and

WHEREAS, the governing body of the City of Rialto has a written labor policy or agreement which specifically provides for the normal member contributions to be paid by the employer, and reported as additional compensation; and

WHEREAS, one of the steps in the procedures to implement Section 20691 is the adoption by the governing body of the City of Rialto of a Resolution to commence paying and reporting the value of said Employer Paid Member Contributions (EPMC); and

WHEREAS, the governing body of the City of Rialto has identified the following conditions for the purpose of its election to pay EPMC;

- This benefit shall apply to all employees of the Rialto Police Management bargaining unit.
- This benefit shall consist of paying 7% of the normal contributions as EPMC, and reporting the same percent (value) of compensation earnable (excluding Government Code Section 20636 (c) (4)) as additional compensation for the miscellaneous employees.
- This benefit shall consist of paying 9% of the normal contributions as EPMC, and reporting the same percent (value) of compensation earnable (excluding Government Code Section 20636 (c) (4)) as additional compensation for the safety employees.
- The effective date of this Resolution shall be April 1, 2010.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

That the governing body of the City of Rialto elects to pay and report the value of EPMC, as set forth above.
