A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, DECLARING THE RESULTS OF THE PROPERTY OWNER PROTEST BALLOT PROCEEDINGS CONDUCTED FOR THE PROPOSED LEVY OF ASSESSMENTS RELATED TO THE ANNEXATION OF TERRITORIES TO THE RIALTO LANDSCAPING AND LIGHTING MAINTENANCE DISTRICT NO. 2, COMMENCING IN FISCAL YEAR 2024/2025

WHEREAS, the City Council of the City of Rialto (the "City") pursuant to the provisions of the Landscaping and Lighting Act of 1972, being Part 2, Division 15 of the California Streets and Highways Code, commencing with Section 22500 (hereafter referred to as the "Act"), did by previous resolutions, initiate proceedings for the annexation of Territories to Landscaping and Lighting Maintenance District No. 2 (the "District"), consisting of PPD 2019-0036 (CROWN ENTERPRISES, INC), PPD 2020-0025 (POBLANO REAL ESTATE HOLDINGS, LLC), (hereinafter referred to as the "Annexation Territories"), and declared its intention to conduct a protest balloting for the levy of new assessments within the Annexation Territories commencing in Fiscal Year 2024/2025 for the special benefits received by properties therein from the improvements related thereto; and,

WHEREAS, in accordance with the provisions of the California Constitution, Article XIIID, the City Council has caused and conducted a property owner protest ballot proceeding for the proposed new assessments to be levied on properties within the Annexation Territories; and,

WHEREAS, the assessments presented to each property owner of record within the Annexation Territories reflects each property's proportional special benefit and financial obligation for the costs and expenses related to the maintenance, servicing and operation of local lighting improvements therein as authorized by the Act and the provisions of the California Constitution and the ballots presented clearly identified the total amount balloted to all properties, the proposed assessment rate, the property's proportional annual amount commencing with Fiscal Year 2024/2025 and the inflationary adjustment applicable to future

assessments; and

WHEREAS, upon the close of the Public Hearing held on March 25, 2025, the protest ballots returned by the landowners of record within the Annexation Territory, were opened and tabulated, the results of which are illustrated below:

9	Annexation Territories, received prior to the close of the public hearing and weighted
10	according to the proportional financial obligation of the affected properties is hereby
11	approved and confirmed.
12	Section 4: The City Clerk is hereby directed to enter this Resolution on the minutes of
13	this meeting, which shall constitute the official declaration of the result of such property
14	owner protest ballot proceeding.
15	Section 5: This Resolution shall become effective immediately upon its adoption and
16	the City Clerk shall certify the adoption of this Resolution.
