3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
4 RIALTO, CALIFORNIA, AMENDING ITS 2024-2025 FISCAL  
5 BUDGET TO INCREASE REVENUE AND APPROPRIATE FUNDS  
6 FOR UNCLAIMED PROPERTY.

7 WHEREAS, the budget for fiscal year 2024-2025 of the City of Rialto has been adopted by this  
8 Council in its original form, and said budget will need to be amended at times to fulfill the goals of the  
9 City; and

10 WHEREAS, the City departments may not exceed their appropriations by character of expense,  
11 with character of expense being defined as personnel services, services and supplies, capital outlay, debt  
12 service and transfers, without the consent of the City Manager; and

13 WHEREAS, the City Manager may transfer appropriations, between departments and within  
14 their respective funds, as long as those appropriations do not exceed their fund total unless approved by  
15 Council.

16 NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES  
17 HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

18 Section 1: Authorize an increase in estimated revenues of \$278,339.44 to the General Fund  
19 Account Number 10106150 47799; and

20 Section 2: Approve an appropriation of \$278,339.44 in the Capital Account Number  
21 33006151 53001.
