3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
4 RIALTO, STATE OF CALIFORNIA, AUTHORIZING THE FILING
5 OF LIENS AGAINST CERTAIN PROPERTIES FOR DELINQUENT
6 REFUSE ACCOUNTS WITH THE SAN BERNARDINO COUNTY
7 RECORDER-CLERK

8 WHEREAS, the City of Rialto, through a franchise agreement with Burrtec Waste
9 Industries, provides for refuse collection services to property owners within the City pursuant
10 to Rialto Municipal Code Chapter 8.08; and,

11 WHEREAS, each owner of such property is liable to pay for the cost of such refuse
12 collection services pursuant to Rialto Municipal Code Chapter 8.08.330(C); and,

13 WHEREAS, each property owner listed on the attached Exhibit A has been billed for
14 refuse service and is delinquent in the payment of such bill for refuse collection by ninety (90)
15 days or more; and,

16 WHEREAS, each property owner listed on the attached Exhibit A was mailed a notice
17 of the City's intent to place a lien on its property from which refuse was collected twenty-one
18 (21) days prior to the public hearing scheduled for September 9, 2025, that the notice advised
19 each property owner of said public hearing wherein the Rialto City Council will consider the
20 imposition of such a lien on the owner's property and hear protests thereto, and advised each
21 property owner of their right to appear at the public hearing to protest the imposition of such a
22 lien on the owner's property. The property totals and corresponding dollar amounts may
23 change in the event that the property owners pay the owed amount prior to the lien being filed
24 with the San Bernardino County Recorder-Clerk's Office; and,

25 WHEREAS, the public hearing was held before the Rialto City Council on September
26 9, 2025, at which the City Council considered the imposition of liens on property for the cost of
27 the refuse collection service provided and administrative costs and heard all protests thereto.

Section 1: The City Council of the City of Rialto, pursuant to Rialto Municipal Code Section 8.08.330 (C), hereby orders the imposition of a lien on each property identified in the attached Exhibit A in the amount set forth in Exhibit A corresponding to each property and that each amount shall constitute a special assessment on each such property which will be placed on the annual San Bernardino County property tax roll.

Section 2: The City Council of the City of Rialto authorizes the City Clerk of the City of Rialto to prepare a certified copy of this Resolution and Exhibit A and directs the City Clerk to record it with the San Bernardino County Recorder-Clerk.
