3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
4 RIALTO, CALIFORNIA, AMENDING ITS 2025-2026 FISCAL
5 BUDGET, ACCEPTING ALLOCATION OF 2025/2026 CITIZENS'
6 OPTION FOR PUBLIC SAFETY (COPS) FUNDING, AND
7 ACCEPTING ALLOCATION OF 2024/2025 CITIZENS' OPTION
8 FOR PUBLIC SAFETY (COPS) GROWTH FUNDING

9 WHEREAS, the budget for fiscal year 2025-2026 of the City of Rialto has been adopted by this
10 Council in its original form, and said budget will need to be amended at times to fulfill the goals of the
11 City; and

12 WHEREAS, the City departments may not exceed their appropriations by character of expense,
13 with character of expense being defined as personnel services, services and supplies, capital outlay, debt
14 service and transfers, without the consent of the City Manager; and

15 WHEREAS, the City Manager may transfer appropriations, between departments and within
16 their respective funds, as long as those appropriations do not exceed their fund total unless approved by
17 Council.

18 NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES
19 HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

20 **Section 1:** Authorize an increase in estimated revenues in 2025/2026 Citizens' Option for
21 Public Safety Fund (COPS), Account No. 22146994 47547 26COP-31 in the amount of \$161,328; and

22 **Section 2:** Authorize an increase in estimated revenues in 2024/2025 Citizens' Option for
23 Public Safety Fund (COPS):

24 Account No. 22146994 47547 25COP-31 in the amount of \$161,656.05; and

25 Account No. 22146994 47405 25COP-31 in the amount of \$135.00,

26 **Section 3:** Approve an appropriation in the in Citizens' Option for Public Safety Fund
27 (COPS):

28 Account No. 22146994 53030 26COP-42 in the amount of \$161,328; and

Account No. 22146994 52021 25COP-42 in the amount of \$161,791.05,

1 for the purchase of technology, communication, equipment, and services for the City of Rialto Police
2 Department.
