3 **A RESOLUTION OF THE UTILITY AUTHORITY OF THE CITY**
4 **OF RIALTO, CALIFORNIA, ADOPTING THE ONE WATER ONE**
5 **WATERSHED PLAN UPDATE 2018, THE INTEGRATED**
6 **REGIONAL WATER MANAGEMENT PLAN FOR THE SANTA**
7 **ANA RIVER WATERSHED**

8 **WHEREAS**, on February 19, 2019, the Santa Ana Watershed Project Authority (SAWPA)
9 Board of Commissioners adopted the One Water One Watershed (OWOW) Plan Update 2018, the
10 Integrated Regional Water Management Plan for the Santa Ana River Watershed, as a planning
11 document outlining a sustainable water future for the Santa Ana River Watershed; and

12 **WHEREAS**, on October 4, 2022, the SAWPA Board of Commissioners considered projects for
13 funding under SAWPAs Round 2 funding allocation of the Water Quality, Supply, and Infrastructure
14 Improvement Act of 2014 (Proposition 1), in which the Rialto Utility Authority is a participant for the
15 Lake Rialto Habitat Management and Community Open Space Project; and

16 **WHEREAS**, as a condition of the grant funding that the Rialto Utility Authority is a recipient to,
17 the Department of Water Resources (DWR) and SAWPA require that all local project sponsors adopt
18 the OWOW Plan Update 2018.

19 **NOW, THEREFORE, THE RIALTO UTILITY AUTHORITY OF THE CITY OF**
20 **RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

21 **Section 1:** The Rialto Utility Authority Executive Director, or designee, is hereby authorized
22 to approve and acknowledge the OWOW Plan Update 2018 and, as a required condition of receiving
23 grant funding under the Plan, adopt the OWOW Plan Update 2018.
