3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
4 RIALTO, CALIFORNIA, APPROVING THE ENGINEER'S
5 REPORT AND ORDERING THE CONTINUED OPERATION AND
6 MAINTENANCE OF IMPROVEMENTS FOR STREET LIGHT
7 MAINTENANCE DISTRICT NO. 1, AND ORDERING THE LEVY
8 AND COLLECTION OF ANNUAL ASSESSMENTS RELATED
9 THERETO FOR FISCAL YEAR 2024/2025

10 **WHEREAS**, the City Council of the City of Rialto, California, (hereinafter the "City
11 Council"), has by previous Resolution established the Street Light Maintenance District No. 1,
12 pursuant to the provisions of the Landscaping and Lighting Act of 1972, Part 2 of Division 15
13 of the Streets and Highways Code of the State of California, beginning with §22500
14 (hereafter referred to as the "Act"), that provides for the levy and collection of assessments
15 by the City of Rialto to pay for the maintenance and service of improvements and all
16 appurtenant facilities and operations related thereto; and

17 **WHEREAS**, an Engineer's Report for Street Light Maintenance District No. 1
18 identifying the levy of assessments for Fiscal Year 2024/2025 (commencing July 1, 2024,
19 and ending June 30, 2025), (hereafter referred to as the "Report"), has been prepared and
20 filed with the City Clerk of the City of Rialto, (hereafter referred to as the "City Clerk"), in
21 accordance with the Act; and the City Clerk has presented to the City Council the Report;
22 and

23 **WHEREAS**, the City Council has carefully examined and reviewed the Report as
24 presented, and is satisfied with each and all of the items and documents as set forth therein,
25 and finds that the levy has been spread in accordance with the special benefits received from
26 the improvements, and the operation, maintenance and services to be performed, as set
27 forth in the Report; and

28 **WHEREAS**, the City Council desires to levy and collect assessments against parcels
of land within Street Light Maintenance District No. 1 for Fiscal Year 2024/2025 (commencing

1 July 1, 2024, and ending June 30, 2025) to pay the costs and expenses of the operation,
2 maintenance, repair and servicing of improvements related thereto; and

3 **WHEREAS**, the Report proposes the levy and collection of annual assessments less
4 than or equal to the maximum assessment amounts previously approved by property owner
5 petition or balloting, in accordance with the provisions of Article XIID of the California
6 Constitution (Proposition 218); and

7 **WHEREAS**, the City Council has noticed and held a Public Hearing on July 23, 2024,
8 regarding Street Light Maintenance District No. 1 and the proposed improvements and
9 assessments for Fiscal Year 2024/2025 (commencing July 1, 2024, and ending June 30,
10 2025) as described in the Report in accordance with the provisions of the Act and applicable
11 provisions of Article XIID of the California Constitution (Proposition 218).

12 **THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND,**
13 **DETERMINE, AND RESOLVE AS FOLLOWS:**

14 **Section 1:** The above recitals are all true and correct.

15 **Section 2:** Following notice duly given, on July 23, 2024, the City Council has held a
16 full and fair Public Hearing to approve or amend the Report, the levy and collection of
17 assessments related thereto, and has considered all oral and written statements, protests
18 and communications made or filed by interested persons. The City Council has determined
19 that the property owners have approved the assessments so presented in the Report in
20 accordance with the requirements of Article XIID of the California Constitution (Proposition
21 218).

22 **Section 3:** Based upon its review (and amendments, as applicable) of the Report, a
23 copy of which has been presented to the City Council and which has been filed with the City
24 Clerk, the City Council hereby finds and determines that:

- 25 a) The land within Street Light Maintenance District No. 1 will receive special benefit by
26 the operation, maintenance, and servicing of certain improvements within the
27 boundaries of Street Light Maintenance District No. 1.
- 28 b) Street Light Maintenance District No. 1 includes all of the lands receiving such special

1 benefit.

2 c) The net amount to be assessed upon the lands within Street Light Maintenance District
3 No. 1 for Fiscal Year 2024/2025 (commencing July 1, 2024, and ending June 30,
4 2025) is apportioned by a formula and method which fairly distributes the net amount
5 among all eligible parcels in proportion to the special benefits to be received by each
6 parcel from the improvements and services.

7 d) The assessment amounts described in the Report do not exceed the maximum
8 assessments previously established in accordance with the provisions of Article XIID of
9 the California Constitution (Proposition 218).

10 **Section 4:** The Report and assessments as presented to the City Council and on file
11 in the Office of the City Clerk are hereby confirmed as filed.

12 **Section 5:** The City Council hereby orders the proposed improvements to be made,
13 which improvements are generally described as the operation, maintenance and servicing of an
14 existing street lighting and electrical system, and publicly maintained trees, and appurtenant
15 facilities and improvements to be provided by the City of Rialto in connection with the
16 improvements installed within Street Light Maintenance District No. 1. The Report describes
17 any new improvements or substantial changes in existing improvements.

18 **Section 6:** The assessments as confirmed shall be submitted to the County Auditor of
19 the County of San Bernardino (the "County Auditor"), and the County Auditor shall enter on the
20 County Assessment Roll opposite each eligible parcel of land the amount of levy so apportioned
21 by the formula and method outlined in the Report, and such levies shall be collected at the
22 same time and in the same manner as San Bernardino County taxes are collected pursuant to
23 §22646 of the Act. After collection by San Bernardino County, the net amount of the levy shall
24 be paid to the City Treasurer.

25 **Section 7:** The City Treasurer shall deposit all money representing assessments
26 collected by San Bernardino County for Street Light Maintenance District No. 1 to the credit of
27 a fund for Street Light Maintenance District No. 1, and such money shall be expended only for
28 the operation, maintenance and servicing of the improvements as described in Section 5.

1 **Section 8:** The adoption of this Resolution constitutes the Street Light Maintenance
2 District No. 1 levy for Fiscal Year 2024/2025 (commencing July 1, 2024, and ending June 30,
3 2025).

4 **Section 9:** The City Clerk is hereby authorized and directed to file the levy with the
5 County Auditor upon adoption of this Resolution.

6 **WHEREFORE,** this Resolution is passed, approved and adopted this 23rd day of July
7 2024.
