f. STAFF UPDATES

November had 23 Shelter Rentals and December has 4 shelter rentals thus far. Our community engagement division has been busy attending events throughout the dept and in the city. They worked on social media campaigns for upcoming events and programs. They launched on the elves on a shelf social media programming. They are prepping and finalizing the progress magazine for the winter spring session. Volleyball registration opened up December 1st. All spaces have been filled for volleyball. Basketball will start on December 8th. Lady Vipers were this season volleyball champions. This seasons basketball champions were Minim Mambas (8-9), Lakers (10-11), and Showstoppers (12-14). Contract classes are going well. Child Development has 30 participants enrolled, they did a fall Coco Sing along event with crafts, a coco bar, and caramel apples. Special Events is preparing for the annual holiday festival and

parade. Snow hill wrist bands are on sale now. Social Recreation is doing well Teen Center hosted an art night, rec and roll is moving to Saturdays during the time change. Fitness & Aquatics is doing well. We continue to get insurance memberships, the black Friday special was the last promotion we did we sold many of those passes, and we had 35 swim lessons offered. They held their annual Turkey Burn which had over 30 participants. Senior Services held their Friendsgiving Raffle.

g. DISCUSSION AND/OR ACTION ITEMS

ITEM: 25-0813 Community Partnership Presentation

- **Friends of the Senior Center**

Eloy and Donna Montoya presented on the friends. Based out of the Senior Center Hold Bingo game fundraising for the center's benefits like the events. Have 15 members on the board. Thank the staff and the city of Rialto for their support.

- **Rialto Family Health Services**

Been at the community center for 10 years. Primary program is for veterans. Has been a CDBG recipient for the past 7 years. The partner with the City, Dignity health, and IEHP. Provide a mobile health clinic once a month, and a diaper give away. IEHP they bring referrals to the community.

- **NCNW**

Based in Rialto for over 50 years. Started in 1969. Built on legacy of leadership, advocacy and service. They focus on empowering women and providing services to the community. They service over 200 clients per year. They provide work force resources, assistance workshops, provide significant volunteer and in-kind contributions. Help with resume writing. Go to the high schools for career day. Ms. Barbara assists Rialto Family Health Services on Friday and works with the Vets. She assists our senior community to get jobs for additional financial security. Hosted job fairs, participated in Shelter Court, Blessings bags, literacy outreach (they give out over 500 books). They would like to do more college fairs, college readiness events. Host weekend events with the youth and job readiness clinics.

- **Rialto Historical Society**

Provided handouts to the commission. Have worked with the department to put up directional signs at the park. They had had hundreds of 3rd glasses visit the Adobe and the Museum. They will have hosted about 1900 students this year. He dresses up a Minor John to give an education tour of the facility. The kids learn that there are no running water or electricity in the building. They learn about pumping water and wells and how they got their water. Next year is the 100th anniversary of route 66. Thousands of people will be coming to see route 66. There is nothing in our town that references route 66.

ITEM: 25-0812 The commission was briefed on the Friends of Rialto Senior Center MOU. They were provided information on the generation of the MOU. The staff have been collaborating with the Friends sub-committee. This MOU will help establish expectations and will hold both agencies accountable to one another to ensure
