



1           **WHEREAS**, the City departments may not exceed their appropriations by character of  
2 expense, with character of expense being defined as personnel services, services and  
3 supplies, capital outlay, debt service and transfers, without the consent of the City  
4 Administrator; and

5           **WHEREAS**, the City Manager may transfer appropriations between departments and  
6 within their respective funds, as long as those appropriations do not exceed their fund total  
7 unless approved by Council.

8  
9           **NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES**  
10 **HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

11           **Section 1:** City Council of the City of Rialto authorizes submittal of a claim and  
12 request for the reimbursement(s) for TDA Article 3 grant funds for the City of Rialto Safe  
13 Routes to School (SRTS) Improvements Project in the amount of \$1,000,000 and that the  
14 City Manager, or their designee, is authorized to certify project completion.

15           **Section 2:** Approve an increase in estimated revenues in the amount of \$1,000,000  
16 to the Grants TDA Article 3 Fund, Account Number 22047326-47536-25085-30; and

17           **Section 3:** Authorize the appropriation of \$1,000,000 from Grants TDA Article 3  
18 Fund, Account Number 22047326-53001-25085-01 for the construction of the City of Rialto  
19 Safe Routes to School (SRTS) Improvements Project expenditures.
