3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
4 RIALTO, CALIFORNIA, AMENDING THE CAPITAL
5 IMPROVEMENT PROGRAM AND AMENDING ITS 2022-2023
6 FISCAL BUDGET TO ADD THE “RIALTO LIBRARY STUDY
7 ROOM PROJECT, CITY PROJECT NO. 230203,” AND
8 APPROPRIATE A BUDGET OF \$700,000.

9 WHEREAS, the budget for fiscal year 2022-2023 of the City of Rialto has been
10 adopted by this Council in its original form, and said budget will need to be amended at times
11 to fulfill the goals of the City; and

12 WHEREAS, the City departments may not exceed their appropriations by character of
13 expense, with character of expense being defined as personnel services, services and
14 supplies, capital outlay, debt service and transfers, without the consent of the City
15 Administrator; and

16 WHEREAS, the City Administrator may transfer appropriations, between departments
17 and within their respective funds, as long as those appropriations do not exceed their fund
18 total unless approved by Council.

19 WHEREAS, the City Council of the City of Rialto requires a five-year Capital
20 Improvement Program (CIP), which is updated annually; and

21 WHEREAS, the CIP may be amended from time to time to include additional capital
22 improvement projects that were not originally identified in the CIP adopted by the City
23 Council.

24 NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES
25 HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

26 Section 1: Approve a revenue increase in the Major Capital Grant Fund, Account
27 No. 223-400-4430-7536-230203 of \$700,000 for a Funding Agreement with the County of
28 San Bernardino.

Section 2: Approve an appropriation from the Major Capital Grant Fund, Account

1 No. 223-500-4430-3001-230203, in the amount of \$700,000,

2 **Section 3:** Amend the Capital Improvement Program (CIP) to include the Rialto
3 Library Study Room Project, City Project No. 230203.

4 **WHEREFORE**, this Resolution is passed, approved and adopted this 15th day of
5 November 2022.
