3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
4 RIALTO, CALIFORNIA, AMENDING THE 2025-2026 FISCAL
5 YEAR BUDGET

6 WHEREAS, the budget for fiscal year 2025-2026 of the City of Rialto has been adopted by this
7 Council in its original form, and said budget will need to be amended at times to fulfill the goals of the
8 City; and

9 WHEREAS, the City departments may not exceed their appropriations by character of expense,
10 with character of expense being defined as personnel services, services and supplies, capital outlay, debt
11 service and transfers, without the consent of the City Manager; and

12 WHEREAS, the City Manager may transfer appropriations, between departments and within
13 their respective funds, as long as those appropriations do not exceed their fund total unless approved by
14 Council.

15 NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES
16 HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

17 Section 1: Authorize an increase in estimated revenues in the Office of Traffic Safety Grant
18 Fund, Account No. 22216996 47551- 26RTL-08 in the amount of \$24,000 for the Office of Traffic
19 Safety – Motorcyclist Safety Education and Training Program Grant.

20 Section 2: Approve an appropriation in the Office of Traffic Safety Grant Fund in the
21 following expenditure accounts:

22 Account No. 22216996 51020 - 26RTL-10 in the amount of \$20,200;

23 Account No. 22216996 51050 - 26RTL-50 in the amount of \$293;

24 Account No. 22216996 52021 - 26RTL-42 in the amount of \$1,007; and

25 Account No. 22216996 52022 – 26RTL-12 in the amount of \$2,500.
