A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, ACCEPTING HOMELESS EMERGENCY AID PROGRAM GRANT FUNDS OF \$600,759, AMENDING ITS 2018-2019 FISCAL BUDGET APPROPRIATING GRANT FUNDS AND AUTHORIZING A TWO-YEAR AGREEMENT WITH THE COUNTY OF SAN BERNARDINO FOR THE HOMELESS MANAGEMENT INFORMATION SYSTEM

WHEREAS, the budget for fiscal year 2018-2019 of the City of Rialto has been adopted by this Council in its original form, and said budget will need to be amended at times to fulfill the goals of the City; and

WHEREAS, the City departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the City Administrator; and

WHEREAS, the City Administrator may transfer appropriations, between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Council.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY
FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

Section 1: To Accept the Homeless Emergency Aid Program Grant in the amount of \$600,759.00; and

Section 2: To authorize appropriation of funding for homeless services related to the Homeless Emergency Aid Grant Contract with County San Bernardino and increase budget of \$600,759 in Account Number 248-400-8812-7560. Approve an appropriation in Homeless Emergency Aid Program Grant Fund:

Account No. 248-500-8810-1001 in the amount of \$ 11,165

Account No. 248-500-8810-1020 in the amount of \$ 21,000

Account No. 248-500-8810-1010 in the amount of \$ 10,000

Account No. 248-500-8810-2011 in the amount of \$500,000

Account No. 248-500-8810-3050 in the amount of \$ 58,594

Section 3: To authorize a two-year Agreement with the County of San Bernardino
