2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIALTO, CALIFORNIA, ACCEPTING HOMELESS EMERGENCY
4 AID PROGRAM GRANT FUNDS OF \$600,759, AMENDING ITS
5 2018-2019 FISCAL BUDGET APPROPRIATING GRANT FUNDS
6 AND AUTHORIZING A TWO-YEAR AGREEMENT WITH THE
7 COUNTY OF SAN BERNARDINO FOR THE HOMELESS MANAGE-
8 MENT INFORMATION SYSTEM

9 WHEREAS, the budget for fiscal year 2018-2019 of the City of Rialto has been adopted
10 by this Council in its original form, and said budget will need to be amended at times to fulfill
11 the goals of the City; and

12 WHEREAS, the City departments may not exceed their appropriations by character of
13 expense, with character of expense being defined as personnel services, services and
14 supplies, capital outlay, debt service and transfers, without the consent of the City
15 Administrator; and

16 WHEREAS, the City Administrator may transfer appropriations, between departments
17 and within their respective funds, as long as those appropriations do not exceed their fund
18 total unless approved by Council.

19 NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY
20 FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

21 Section 1: To Accept the Homeless Emergency Aid Program Grant in the amount of
22 \$600,759.00; and

23 Section 2: To authorize appropriation of funding for homeless services related to the
24 Homeless Emergency Aid Grant Contract with County San Bernardino and increase budget of
25 \$600,759 in Account Number 248-400-8812-7560. Approve an appropriation in Homeless
26 Emergency Aid Program Grant Fund:

27 Account No. 248-500-8810-1001 in the amount of \$ 11,165

28 Account No. 248-500-8810-1020 in the amount of \$ 21,000

Account No. 248-500-8810-1010 in the amount of \$ 10,000

Account No. 248-500-8810-2011 in the amount of \$500,000

Account No. 248-500-8810-3050 in the amount of \$ 58,594

Section 3: To authorize a two-year Agreement with the County of San Bernardino
