17	Section 1: Authorize an increase in revenues in the General Fund – Healthy Community
18	Account No. 22233165-47560 in the amount of \$15,000; and

20	Section 2: Approve an appropriation of \$15,000 in General Fund – Healthy Community
21	Account No. 22233165-52021 for expenditures related to the grant.
