A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, ACCEPTING THE GRANT FROM CALIFORNIA DEPARTMENT OF TRANSPORTATION DIVISON OF TRANSPORTATION PLANNING FOR THE ROAD REPAIR AND ACCOUNTABILITY ACT OF 2017 SUSTAINABILITY COMMUNITIES GRANT FOR A RIALTO MULTI-MODAL FEASIBILITY STUDY; AND APPROVE A BUDGET ADJUSTMENT TO ACCOUNT FOR THE RECEIPT AND APPROPRIATION OF THE GRANT FUNDS

WHEREAS, the City of Rialto is eligible to receive State funding from the California Transportation Commission; and

WHEREAS, the measures proposed in the Road Repair and Accountability Act of 2017 (Senate Bill [SB] 1, Chapter 5, Statutes of 2017) created the Local Partnership Program; and

WHEREAS, two hundred million dollars (\$200,000,000) annually is to be allocated by the California Transportation Commission to local or regional transportation agencies that have sought and received voter approval of taxes or that have imposed fees, which taxes or fees are dedicated solely for transportation improvements; and

WHEREAS, the City of Rialto, if selected, will enter into an agreement with the State of California Transportation Commission to carry out the project;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES
HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

Section 1: Accepting the California Department of Transportation (Caltrans), Division of Transportation Planning FY2017-2018 Sustainable Communities Grant under the Road Repair and Accountability Act of 2017 (Senate Bill (SB) 1) for an Multi-Modal Feasibility Study, and

Section 2: Authorize the City Administrator, or designee of the City of Rialto, as agent to conduct all negotiations, execute and submit all documents including, but not limited to applications, agreements, and payment requests and so on, which may be necessary for the completion of the aforementioned project(s)

Section 3: Approve an increase in estimated revenues in the amount of \$200,000 to the Grants Project Fund, Account Number 223-400-4427-7536-180809-22 for the Sustainable Communities Planning Grant.

1 **Section 4:** Authorize the appropriation of \$200,000 in Grants Project Fund, Account Number
2 223-500-4427-2011-180809-01 for the Sustainable Communities Planning Grant, and \$26,000 in
3 Measure I Fund, Account Number 201-500-4310-2011-180809-04.

4 **Section 5:** The City Clerk shall certify as to the adoption of this Resolution as of the date set
5 forth below.
