RESOLUTION NO. 5771

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, TO TAX DEFER EMPLOYEE MEMBER PAID CONTRIBUTIONS

WHEREAS, the governing body of the City of Rialto has the authority to implement Government Code Section 20691; and

WHEREAS, the governing body of the City of Rialto has written labor policy or agreement which specifically provides for the normal member contributions to be paid by the employer; and

WHEREAS, one of the steps in the procedures to implement Section 20691 is the adoption by the governing body of the City of Rialto of a Resolution to commence said Employer Paid Member Contributions (EPMC); and

WHEREAS, the governing body of the City of Rialto has identified the following conditions for the purpose of its election to pay EPMC:

- This benefit shall apply to all employees of Rialto Professional Firefighters Local 3688 bargaining unit;
- This benefit shall consist of 6.5% paid by the employees of Local 3688 and 2.5% paid by the City of Rialto as EPMC; and
- The effective date of this Resolution shall be the pay period beginning December 20, 2009, and the pay period ending July 31, 2010.






