## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, TO TAX DEFER EMPLOYEE MEMBER PAID CONTRIBUTIONS

**WHEREAS**, the governing body of the City of Rialto has the authority to implement Government Code Section 20691; and

WHEREAS, the governing body of the City of Rialto has written labor policy or agreement which specifically provides for the normal member contributions to be paid by the employer; and

WHEREAS, one of the steps in the procedures to implement Section 20691 is the adoption by the governing body of the City of Rialto of a Resolution to commence said Employer Paid Member Contributions (EPMC); and

**WHEREAS**, the governing body of the City of Rialto has identified the following conditions for the purpose of its election to pay EPMC:

- This benefit shall apply to all employees of Rialto Professional Firefighters Local 3688 bargaining unit;
- This benefit shall consist of 6.5% paid by the employees of Local 3688 and 2.5% paid by the City of Rialto as EPMC; and
- The effective date of this Resolution shall be the pay period beginning December 20, 2009, and the pay period ending July 31, 2010.

## NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

That the governing body of the City of Rialto elects to pay and report the value of EPMC, as set forth above.
