RESOLUTION NO. 7932 1 2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA 3 RECEIVING AND APPROVING A RESOLUTION APPROVING THE FISCAL YEAR 2022-2023 ANNUAL ACTION PLAN (AAP); AUTHORIZING THE CITY MANAGER TO 4 SUBMIT THE AAP TO THE U.S. DEPARTMENT OF HOUSING AND URBAN 5 DEVELOPMENT (HUD); AND AUTHORIZING THE CITY MANAGER TO TAKE ALL ACTIONS NECESSARY TO IMPLEMENT THE PROGRAMS IDENTIFIED IN THE AAP 6 7 WHEREAS, HUD requires all jurisdictions that receive federal entitlement funds to prepare an 8 Annual Action Plan that identifies the projects to be funded with Community Development Block Grant 9 (CDBG) and HOME Investment Partnerships ("HOME"); and 10 **WHEREAS**, the City of Rialto (the "City") prepared and adopted a Five-Year Consolidated Plan 11 for the City covering the period July 1, 2020 to June 30, 2024; and 12 13 **WHEREAS**, the purpose of the Consolidated Plan and the Annual Action Plan is to identify 14 housing and community development needs and to develop specific goals and objectives to address those 15 needs over a five-year period and is a requirement of the U.S. Department of Housing and Urban 16 Development that the City must meet in order for the City to continue to receive federal housing and 17 community development funds; and 18 19 WHEREAS, City staff published a public notice announcing the availability of the draft Annual 20 Action Plan in the San Bernardino County Sun on March 28, 2022, triggering a 30-day public comment 21 period. 22 23 NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY 24 **RESOLVE AS FOLLOWS:** 25 26 **SECTION 1.** The above recitals are true and correct and incorporated herein by reference. 27

SECTION 2. The City Council of the City of Rialto does hereby adopt the 2022-2023 Annual 1 Action Plan. 2 3 **SECTION 3**. The City Manager is hereby authorized to make all conforming modifications and 4 edits and to execute all implementing documents required by HUD to receive and reallocate funding 5 identified under the approved Annual Action Plan. 6 7 **SECTION 4**.
