**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, AMENDING ITS 2025-2026 FISCAL BUDGET AND APPROPRIATING CAPITAL PROJECTS FUND BALANCE FOR FIRE STATION 201 SAFETY IMPROVEMENTS PROJECT, CITY PROJECT NO. 25021.**

**WHEREAS**, the budget for fiscal year 2025-2026 of the City of Rialto has been adopted by this Council in its original form, and said budget will need to be amended at times to fulfill the goals of the City; and

**WHEREAS**, the City departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the City Manager; and

**WHEREAS**, the City Manager may transfer appropriations between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Council.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES  
HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

**Section 1:** Authorize an appropriation of \$937,665 from the Capital Improvement Projects Fund balance to Account No. 33007302-53001-25021-05 for the Fire Station 201 Safety Improvements project, City Project No. 25021.

**Section 2:** Authorize an appropriation of \$188,965.88 from the Capital Improvement Projects Fund balance to Account No. 33007302-53001-25021-16 for the Fire Station 201 Safety Improvements project, City Project No. 25021.
