3 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF**
4 **RIALTO, CALIFORNIA, ORDERING THE PREPARATION OF AN**
5 **ENGINEER’S REPORT FOR STREET LIGHT MAINTENANCE**
6 **DISTRICT NO. 1 TO ESTABLISH ANNUAL ASSESSMENTS**
7 **FOR FISCAL YEAR 2025/2026.**

8 **WHEREAS**, the City Council of the City of Rialto, California, (hereinafter the “City
9 Council”), has by previous Resolution established the Street Light Maintenance District No. 1,
10 pursuant to the provisions of the Landscaping and Light Act of 1972, Part 2 of Division 15 of
11 the Streets and Highways Code of the State of California, beginning with §22500 (hereafter
12 referred to as the “Act”), that provides for the levy and collection of assessments by the City
13 of Rialto to pay for the maintenance and services of improvements and all appurtenant
14 facilities and operations related thereto; and

15 **WHEREAS**, §22566 and §22622 of the Act requires the preparation of an Engineer’s
16 Report to determine and adjust the annual assessment rates for Street Light Maintenance
17 District No. 1.

18 **NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES**
19 **HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

20 **Section 1:** Webb Municipal Finance, LLC is hereby ordered to prepare and
21 appropriately file the Engineer’s Report required to determine and adjust the Street Light
22 Maintenance District No. 1 assessments for Fiscal Year 2025/2026 in accordance with
23 §22566 and §22622 of the Act. The Engineer’s Report shall be filed with the City Clerk for
24 submission to the City Council.

25 **Section 2:** The improvements to be operated and maintained by Street Light
26 Maintenance District No. 1 generally include the operation, administration, maintenance, and
27 servicing of street Light, and street tree maintenance, and appurtenant facilities and
28 expenses associated with Street Light Maintenance District No. 1 that will be maintained by
the City of Rialto through annual assessments.

1 **Section 3:** The improvements to be maintained by the City of Rialto for Fiscal Year
2 2025/2026 are substantially the same as the improvements provided and maintained in the
3 previous Fiscal Year and the Engineer’s Report for Street Light Maintenance District No. 1
4 prepared in connection therewith shall describe the improvements as required by the Act.

5 **Section 4:** The Engineer’s Report for Street Light Maintenance District No. 1 shall
6 reflect provisions and related assessments in accordance with the requirements of Articles
7 XIIIIC and XIIID of the California Constitution as enacted by the passage of Proposition 218,
8 also referred to as “The Right to Vote on Taxes Act,” as approved by the voters of the State of
9 California on November 5, 1996.

10 **Section 5:** The Engineer’s Report for Street Light Maintenance District No. 1 shall be
11 titled: “City of Rialto, Street Light Maintenance District No. 1, Engineer’s Report, Fiscal Year
12 2025/2026.”

13 **Section 6:** The City Clerk shall certify to the adoption of this Resolution.

14 **WHEREFORE,** this Resolution is passed, approved and adopted this 10th day of June
15 2025.
