## A RESOLUTION OF THE RIALTO UTILITY AUTHORITY OF THE CITY OF RIALTO, CALIFORNIA, DIRECTING THE PLACEMENT OF WASTEWATER CHARGES DELINQUENT AS OF JUNE 24, 2025, ON THE PROPERTY TAX BILLS FOR COLLECTION

WHEREAS, Section 12.08.201 of the Rialto Municipal Code provides that delinquent wastewater changes are considered for submittal to the County of San Bernardino to be included on the Annual Property Tax bill as a lien; and

WHEREAS, California Health and Safety Code Section 5473 authorizes the Rialto Utility Authority to levy and collect wastewater charges through county-administered and enforced property tax billing and collection procedures; and

WHEREAS, the Auditor-Controller of San Bernardino County is authorized, if so directed by the Rialto Utility Authority, to place wastewater charges on the property tax rolls; and

WHEREAS, the Rialto Utility Authority has elected to transition the placement of delinquent wastewater charges on the property tax rolls; and

WHEREAS, on July 22, 2025, at 6:30 p.m. at the Rialto City Hall, City Council Chambers, the Rialto Utility Authority held a duly-noticed public hearing to consider the placement of the wastewater charges on the property tax bills of all properties with delinquent charges as of the latest County Secured Property Tax Roll and as identified on Exhibit "A", considered all documentary evidence and verbal testimony and closed the Public Hearing.

NOW, THEREFORE, THE RIALTO UTILITY AUTHORITY OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

<u>Section 1</u>. Having found that the Rialto Utility Authority duly issued noticed of the proposed assessment liens to all addresses shown on the official records of the San Bernardino County Assessors Secured Property Tax Roll and that the property owners identified on Exhibit "A" hereto have failed to pay the required fee to the Rialto Utility Authority or file any written appeal to the proposed assessment lien, s required under Rialto Municipal Code section 12.08.201, the delinquent wastewater charges as of June 24, 2025, of those customers who maintain ownership of the property with delinquent charges as of the latest County Secured Property Tax Roll and as identified on Exhibit "A" are hereby approved for levy on the annual property tax bill of the respective properties and shall be forwarded to the County of San Bernardino for addition to the Fiscal Year 2025/2026 property tax rolls as a special assessment.

<u>Section 2</u>. The Rialto Utility Authority Board of Directors of the City of Rialto authorizes the City Clerk of the City of Rialto to prepare a certified copy of this RUA Resolution and Exhibit A and directs the City Clerk to record it with the San Bernardino County Recorder.
