To Whom It May Concern:

This letter confirms that Park Consulting Group, is the sole-source provider in the United States of full-service implementation services for required activities and deliverables that Tyler Tech requires their clients to own and are responsible for during Enterprise Permitting & Licensing System (EPL, EnerGov) Projects.
