

1 **RUA RESOLUTION NO. XX-XX**

2 **A RESOLUTION OF THE RIALTO UTILITY AUTHORITY BOARD OF THE**  
3 **CITY OF RIALTO, CALIFORNIA AMENDING ITS 2025-2026 WASTEWATER**  
4 **FISCAL YEAR BUDGET IN FUND 680.**

5 WHEREAS, the budget for fiscal year 2025-2026 of the Rialto Utility Authority has been adopted  
6 by this Board in its original form, and said budget will need to be amended at times to fulfill the goals of  
7 the Board; and

8 WHEREAS, the Rialto Utility Authority may not exceed their appropriations by character of  
9 expense, with character of expense being defined as personnel services, services and supplies, capital  
10 outlay, debt service, and transfers, without the consent of the Executive Director; and

11 WHEREAS, the Executive Director may transfer appropriations between departments and within  
12 their respective funds, as long as those appropriations do not exceed their fund total unless approved by  
13 the Board.

14 NOW, THEREFORE, BE IT RESOLVED BY THE RIALTO UTILITY AUTHORITY OF THE  
15 CITY OF RIALTO AS FOLLOWS:

16 Section 1. The above recitals are true and correct.

17 Section 2. The Rialto Utility Authority Board hereby approves a new appropriation to the  
18 Wastewater Concession Agreement Fund in Contract Services Account No. 56807860-52011 in the  
19 amount of \$72,000.

20 Section 3. The Rialto Utility Authority's Executive Director or their designee is hereby  
21 authorized and directed to execute the Budget Amendment and any amendments thereof.

22 Section 4. This resolution shall take effect immediately upon its passage.
