3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
4 RIALTO, CALIFORNIA, APPROVING THE PUBLIC
5 IMPROVEMENT AGREEMENT FOR PUBLIC IMPROVEMENTS
6 ALONG RIVERSIDE AVENUE AND SANTA ANA AVENUE
7 RELATED TO THE PRECISE PLAN OF DESIGN (PPD) 2023-0025
8 FOR THE DEVELOPMENT OF 3.88 ACRES WITH AN ELECTRIC
9 TRUCK CHARGING CENTER WITH 73 CHARGING STATIONS
10 AND ASSOCIATED PAVING, LANDSCAPING, SCREEN WALLS,
11 LIGHTING, AND DRAINAGE IMPROVEMENTS.

13 **WHEREAS**, the Community Development Director of the City of Rialto, on April 9, 2024,
14 approved PPD 2023-0025 subject to conditions; and

15 **WHEREAS**, OLAM S Riverside Ave LLC (hereinafter the "Developer"), has submitted a
16 Public Improvement Agreement with security; and

17 **WHEREAS**, not all public improvements have been completed by the Developer prior
18 to issuance of building permits, and the Developer has requested that the City enter into a
19 Public Improvement Agreement with the Developer to secure the cost of public improvements.

20 **NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY**
21 **FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

22 **Section 1:** Requisite conditions associated with PPD 2023-0025 have been satisfied
23 or supported with the necessary security for construction of improvements.

24 **Section 2:** The City Council hereby approves a Public Improvement Agreement for
25 PPD 2023-0025 with the Developer and accepts public improvement securities in conformance
26 with the requirements therein for public improvements. The City Manager is hereby authorized
27 to execute the Public Improvement Agreement on behalf of the City.

28 **Section 3:** The City Clerk shall cause to have recorded with the San Bernardino
County Recorder the Public Improvement Agreement.
