A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, AMENDING ITS 2024-2025 FISCAL BUDGET, ACCEPTING ALLOCATION OF 2024/2025 CITIZENS' OPTION FOR PUBLIC SAFETY (COPS) FUNDING, AND ACCEPTING ALLOCATION OF 2023/2024 CITIZENS' OPTION FOR PUBLIC SAFETY (COPS) GROWTH FUNDING

WHEREAS, the budget for fiscal year 2024-2025 of the City of Rialto has been adopted by this Council in its original form, and said budget will need to be amended at times to fulfill the goals of the City; and

WHEREAS, the City departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the City Manager; and

WHEREAS, the City Manager may transfer appropriations, between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Council.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

Section 1: Authorize an increase in estimated revenues in 2024/2025 Citizens' Option for Public Safety Fund (COPS), Account No. 22146994 47547 25COP-31 in the amount of \$159,210; and

Section 2: Authorize an increase in estimated revenues in 2023/2024 Citizens' Option for Public Safety Fund (COPS):

Account No. 22146994 47547 188 in the amount of \$151,577.28; and

Account No. 22146994 47405 188 in the amount of \$46.94

Section 3: Approve an appropriation in the in Citizens' Option for Public Safety Fund (COPS):

Account No. 22146994 52021 25COP-42 in the amount of \$159,210; and

Account No. 22146994 52021 188 in the amount of \$151,624.22,

1 for the purchase of technology, communication, equipment, and services for the City of Rialto Police
