

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
RIALTO, CALIFORNIA, APPROVING TRACT MAP 20356 FOR
THE SUBDIVISION OF THREE (3) PARCELS OF LAND INTO
SEVEN (7) CONDOMINIUM PARCELS

WHEREAS, the Planning Commission of the City of Rialto, at its meeting of February 22, 2023, approved Tentative Tract Map 20356 subject to conditions; and

WHEREAS, Keystone DCS, Inc. (hereinafter the "Subdivider"), has filed Tract Map 20356 with the City Council of the City of Rialto, (hereinafter the "City"), in accordance with Section 66456 of the California Government Code; and

WHEREAS, not all public improvements have been completed by the Subdivider as of the filing of Tract Map 20356, and the Subdivider has requested that the City enter into a Subdivision Improvement Agreement with the Subdivider to secure the cost of public improvement in accordance with Section 66462 of the California Government Code.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY
FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

Section 1: Tract Map 20356 is in substantial conformance with the approved Tentative Tract Map 20356.

Section 2: Requisite conditions associated with Tract Map 20356 have been satisfied or supported with the necessary bonds for construction improvements.

Section 3: Tract Map 20356 is in conformance with the General Plan and Foothill Boulevard Specific Plan.

Section 4: Tract Map 20356 conforms to all applicable requirements of the Subdivision Map Act of the State of California.

1 **Section 5:** In accordance with Section 66477.1 of the California Government Code,
2 the offers of dedication to the public on Tract Map 20356 shall be accepted by the City Clerk,
3 subject to improvement, who shall certify acceptance by signature on the map thereof.

4 **Section 6:** The City Council hereby approves a Subdivision Improvement Agreement
5 for Tract Map 20356 with the Subdivider, Keystone DCS, Inc., and accepts subdivision
6 improvement securities in conformance with the requirements therein for public improvements.
7 The City Manager is hereby authorized to execute the Subdivision Improvement Agreement
8 on behalf of the City.

9 **Section 7:** The City Clerk shall cause to have recorded with the San Bernardino
10 County Recorder the Subdivision Improvement Agreement.

11 **Section 8:** Tract Map 20356 is hereby approved for the purposes therein defined.
