2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
3 RIALTO, CALIFORNIA, AMENDING THE FISCAL YEAR 2025-  
4 2026 CAPITAL IMPROVEMENT PROJECT BUDGET TO  
5 INCORPORATE SAN BERNARDINO COUNTY FUNDS FOR THE  
6 CACTUS TRAIL LIGHTING PROJECT, CITY PROJECT NUMBER  
7 26088.

8 WHEREAS, the budget for fiscal year 2025-2026 of the City of Rialto has been  
9 adopted by this Council in its original form, and said budget will need to be amended at times  
10 to fulfill the goals of the City; and

11 WHEREAS, the City departments may not exceed their appropriations by character of  
12 expense, with character of expense being defined as personnel services, services and  
13 supplies, capital outlay, debt service and transfers, without the consent of the City Manager;  
14 and

15 WHEREAS, the City Manager may transfer appropriations between departments and  
16 within their respective funds, as long as those appropriations do not exceed their fund total  
17 unless approved by Council.

18 NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES  
19 HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

20 Section 1: Authorize an increase in revenue in account number 22234429-  
21 47583 in the amount of \$859,100 for the Cactus Trail Solar Lighting project, City project  
22 number 26088.

23 Section 2: Authorize increasing the budget in account number 22234429-53001 in  
24 the amount of \$859,100 for the Cactus Trail Solar Lighting project, City project number  
25 26088.
