

1 destroy and remove them from the parcels of property and the cost thereof shall become lien on each
2 parcel of property set forth in Exhibit “A” from which the weeds were destroyed and removed.

3 **Section 5.** The City Clerk is hereby directed to mail written notice of the proposed abatement
4 and public hearing thereon to all persons owning the parcels of property described in Exhibit “A.” Said
5 notice shall be mailed at least 5 days prior to the time for hearing objections by the City Council.

6 **Section 6.** The notice mailed by the City Clerk shall comply with all provisions set forth in
7 Section 39567.1 of the California Government Code and shall be in substantially the same form as the
8 notices attached hereto as Exhibit “B” and Exhibit “C.”

9 **Section 7.** Any parcel of property not abated by the owner thereof by May 15, 2024,
10 and October 1, 2024, in accordance with this Resolution shall be abated by the contractor selected by the
11 City of Rialto, as directed by and in a manner approved by the Fire Chief. All costs of such abatement
12 will be the responsibility of the property owner.

13 **Section 8.** The City Council shall hold a public hearing for the purpose of hearing any and all
14 objections to the proposed resolution for the removal of weeds, rubbish and refuse upon private property,
15 and dirt upon the parkways and sidewalks, and to impose the abatement cost therefore as a lien against
16 the parcels of property set forth in Exhibit “A” hereto at its regular Council Meeting on April 23, 2024,
17 at 6:30 p.m. in the Council Chambers. Any property owner who fails to appear and object to the order
18 to abate the weeds upon each owner’s parcel of property shall waive the owner’s right to contest
19 this abatement order and the cost of the abatement.

20 **Section 9.** The contractor’s costs and a separate administrative fee of \$149.00 per parcel will
21 be charged each time that the weeds upon a parcel identified in Exhibit “A” is abated.

22 **Section 10.** Upon the conclusion of the Weed Abatement Program, all costs of abatement,
23 including the contractor’s costs and the administrative fees, shall be placed on the San Bernardino County
24 Property Tax Rolls for each parcel.
